**Cape May Court House, New Jersey** – County Prosecutor Robert L. Taylor announced the conclusion of a one-month undercover narcotics investigation involving the Prosecutor's Office Gangs, Guns and Narcotics Task Force, Wildwood Police Department and the North Wildwood Police Department.

On February 19, 2010, members of the Cape May County Regional SWAT Team; Cape May County Prosecutor's Office; Wildwood Police Department and North Wildwood Police Department, executed court authorized search warrants at 231 E. Lincoln Avenue, Wildwood, 140 E. Leaming Avenue, Apartment 5, Wildwood, and 107 West 24<sup>th</sup> Avenue, North Wildwood. As a result of this investigation, the following subjects were arrested:

Ronnie Gerald, 28 years of age, residing at 107 W. 24<sup>th</sup> Ave., North Wildwood, charged with Possession of under ½ ounce of cocaine, Possession with the intent to distribute, Possession of CDS within one-thousand (1,000) feet of a school zone, Possession of CDS within five hundred (500) feet of a public place, Possession of marijuana under fifty (50) grams and 2<sup>nd</sup> Degree Child Endangerment.

Heather Ramsey, 31 years of age, residing at 107 W. 24<sup>th</sup> Ave., North Wildwood, charged with Possession of under ½ ounce of cocaine, Possession with the intent to distribute, Possession of CDS within one-thousand (1,000) feet of a school zone, Possession of CDS within five hundred (500) feet of a public place, Possession of marijuana under fifty (50) grams and 2<sup>nd</sup> Degree Child Endangerment.

Guy Bruce, 27 years of age, residing at 231 E. Lincoln Ave., Room 201, Wildwood, was charged with Possession of CDS, specifically crack-cocaine under ½ Ounce and heroin, along with Distribution of CDS.

David Johnson, 29 years of age, residing at 140 E. Leaming Ave., Apt. 5, Wildwood, was charged with Possession of marijuana under fifty (50) grams, Possession of Hypodermic Syringes and Possession of Paraphernalia.
